

#### **Burn Mechanism**

Beginning in Q4 2025, Extsy will introduce a structured burn mechanism. Each quarter, 25% of Extsy's gross trading fee revenue will fund buybacks of XTSY, and the repurchased tokens will then be burned and permanently removed from circulation. This approach links platform activity to token supply in a clear, predictable way and supports a healthy, transparent economy, consistent with the program terms outlined above.






